

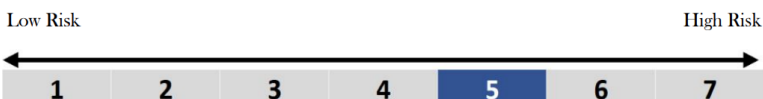

Portfolio Objective and Strategy

The principal investment objective of the Fund is to achieve medium to long term capital appreciation at the risk of moderate short-term volatility of capital values. The Fund is Diversified CIS designed to maximise returns. It will be diversified across asset classes and regions. The investment objective is to achieve medium to long term capital growth through exposure to selected sectors of the global equity market, bond market and money market.

The Fund is aimed at investors with a medium to long term (4 to 6 years) investment time horizon. This Fund is best suited for investors who can accept some volatile capital movements but seek consistent returns.

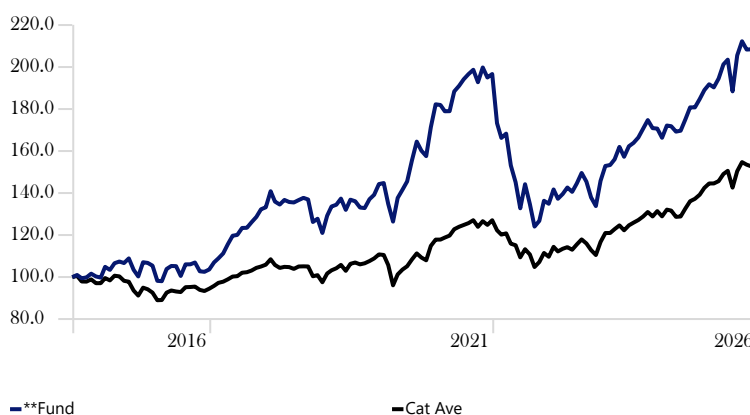
Monthly Commentary

The Iza Global Balanced Fund delivered a strong return of 2,41% (GBP) and 2,91% (USD) during August, bringing its year-to-date return to 9,67% (GBP) and 10,27% (USD). The Fund outperformed its peer benchmark during the month in both currencies (benchmark returns of 1,83% (GBP) and 2,28% (USD)) and extended its outperformance on a year-to-date basis (benchmark returns of 6,95% (GBP) and 6,71% (USD)). Longer-term performance also remained solidly ahead of benchmark, with Fund returns of 15,71% (GBP) and 16,09% (USD) over one year (versus benchmark returns of 12,11% (GBP) and 12,16% (USD)) and 21,68% (GBP) and 25,61% (USD) over two years (versus benchmark returns of 18,81% (GBP) and 21,16% (USD)).

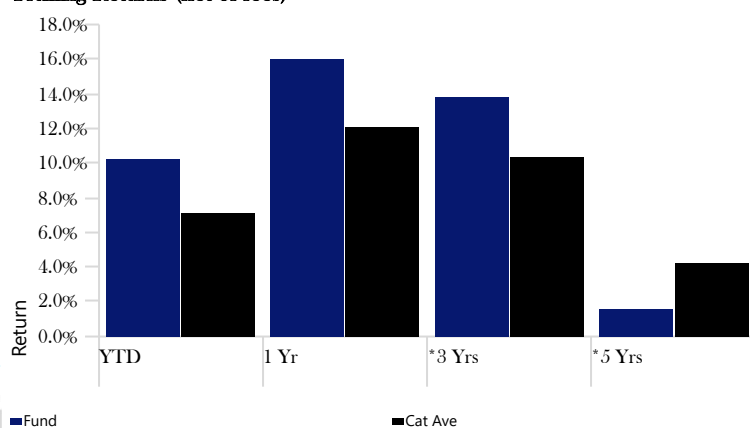
August marked a decisive rebound for the Fund following July's weakness, with broad-based gains across equities, alternative assets and structured products. The strongest performing underlying holdings during the month were gold, delivering a positive return of 9,39% as precious metals rallied sharply, the Santander Note (NKY/SX5E/MXEF), delivering a return of 6,94%, and the Artemis SmartGARP Global Equity Fund, delivering a return of 4,44%. There were no material detractors during the month.

In August, our top contributions to performance came from the iShares MSCI World USD allocation, which contributed 0,67%, Jupiter World Equity Fund, which contributed 0,37%, and gold, which contributed 0,30% following its strong rally over the month. Given the broad-based nature of the gains, detractors had only a marginal impact on overall performance.

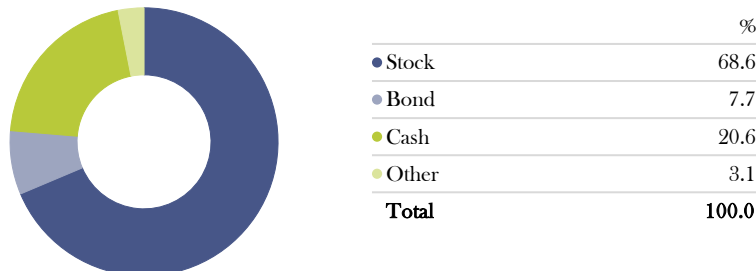

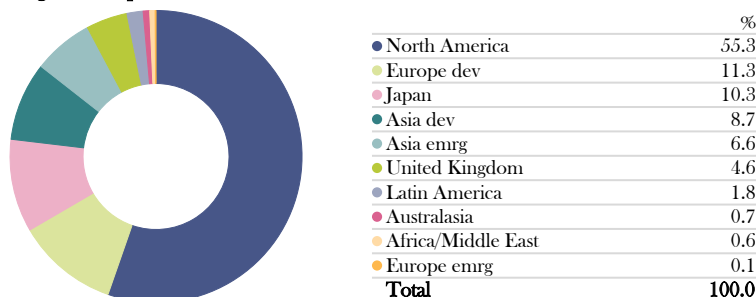

Glossary of Terms

Standard Deviation is a measure of the dispersion of a set of data from its mean. When applied to an annual rate of return it sheds light on the historical volatility of the investment.

Sharpe Ratio is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk.

Maximum Drawdown is the is measure of the the maximum observed loss from a peak to trough of a portfolio, before a new peak is attained. It is a an indicator of downside risk over a given period.

Sortino Ratio is a measure for calculating the performance of an investment relative to its downside deviation. It is the average return earned in excess of the risk-free rate divided by the investments' downside risk.
